These are the highlights if you are not signed in or are not a member but would like to know more about the volunteer program.

- 1. Volunteer entries for awards must be approved by the executive committee (i.e. officers) and officers will not be eligible for awards.
- 2. Volunteer entries are not for attendance of Board or committee meetings or Timely Topics or other LWV educational "pay" events such as conferences. Tabling events, petition collection, observer corps, speaker's bureau, and other volunteer needs beyond normally scheduled business meetings and events are the intent of this program.
- 3. The program will be per fiscal year (April 1 to March 30) with the exception of entries from Sept 2017 to April 2018 will be added to the next fiscal year as part of program initiation and testing.
- 4. A coupon for a free pass to a LWVSC event will be awarded to any members who accumulate 24 volunteer hours. Hours will be tallied and awards made every quarter, the 24 hours will be deducted from a member's total hours once the coupons are presented.
- 5. The intent of this program is to get membership involved and looking at our volunteer page. We will evaluate the effectiveness at the end of the first full fiscal year it is implemented and

# FLORIDA CONSTITUTION REVISION COMMISSION (CRC) PUBLIC HEARING IN BREVARD COUNTY ON FEBRUARY 19, 2018

We will recall that Florida's Constitution Revision Commission (CRC) convenes every 20 years. The third one was organized at the beginning of last year, 2017, and has been meeting since then. As provided by the Florida Legislature, it has 37 members appointed by various Florida governmental leaders (Governor – 15, Senate President – 9, House Speaker – 9, Supreme Court Chief Justice – 3, plus the Florida Attorney General).

The CRC has the ability, by the vote of 22 of its 37 members, to place on the November 2018 ballot any changes to Florida's Constitution that it desires. This is a very great power, especially when one notes that to place an Amendment on the ballot by citizen initiative requires the certified petitions of 766,200 voters (22 vs 766,200!).

During this past summer and fall the CRC accepted more than 1,400 proposed Constitutional Amendments from citizens and from its own members. Those proposals have been reviewed by the CRC's several Committees, and the number to be given further consideration has been reduced to 103.

Under the rules governing the CRC, May 10, 2018 is the deadline to submit its final report to the Florida Secretary of State. It must report by then exactly what proposed Amendments it will present to Florida's voters in November. The approval of 60% of the voters is required to add any Amendment to the Constitution. Interestingly, in 1978 the first CRC proposed eight Amendments and none were approved by the voters. In 1998 nine Amendments were proposed and eight passed, with only a majority vote (50 %) being required in both instances.

In order to help make its final decisions, the CRC has scheduled six public hearings to be held around Florida during this February and March. One of those hearings will be held here in Brevard County, at the King Center of Eastern Florida State College, on Monday, February 19<sup>th</sup>.

The King Center hearing is scheduled to be held from 1:00 to 7:00 PM that day. However, it will continue into the evening until all those present have had an opportunity to speak and express their views on any of the proposed Amendments (The CRC hearing announcement states, "Floridians who fill out an appearance form by 7:00 PM local time will be given an opportunity to speak before the Commission.").

There are a number of issues still being considered by the CRC that are of great interest to the Florida LWV and to our Space Coast LWV. They include: Everyone's Right to a Clean and Healthful Environment; Land Acquisition Trust Fund Financing; Handgun Licensing; Public Education, including use of Public Funds for Private Schools and Authorization of Public School Boards to Convert to Charter Schools; Restoration of Voting Rights for Former Non-Violent Felons; Voting in Primary Elections and more.

All Brevard County citizens, especially those reading this report, are encouraged to attend the hearing. And, if they are able, to participate in the public discussion. Because speakers will likely be called in the order they submit an "appearance form", try to come to the hearing as early as possible.

- The Natural Resource Meeting at the Cocoa Library on Saturday, February 24<sup>th</sup> will have a discussion of Solid Waste Recycling. Meeting is from 3 p.m. to 4:30 p.m.
- Susan Little, Chair of Natural Resources
   Committee recommends the book *Climate of Hope* by Michael Bloomberg and Carl Pope. It is a discussion of how cities and individuals will tackle climate change.
- Thank you to Tony Dutton who is responsible for our League receiving a grant of \$900 to carry out a student voter registration project in 2018.
- Terry Mott purchased one of Brevard Zoos' newly created *Sustainability Survival Kits* to be given away at the January Celebrate the League event on January 18<sup>th</sup>. The kits were created to encourage people to reduce the use of disposable food-related products such as plastic straws, cutlery and Styrofoam containers. The kit includes the following items: an insulated lunch bag, a dishwasher-safe food container, spoon, fork, a pouch with reusable chopsticks, a reusable straw, straw cleaning brush and a cloth napkin. The kits are a fundraiser program for the Zoo and the basic version costs \$30. For an additional \$15 one receives a Tervis water bottle.



## International Relations Joyce Calese - Chair

The February International Relations meeting will be at the Satellite Beach Library on Tuesday, February 13 from 1 p.m. to 3 p.m. Topic is Russia's Foreign Policy led by Jane Wilson

At the December International Relations meeting we received such interesting and timely information from our speaker Molly Tasker. Molly is a League member, attorney and is very well informed since she has worked for the federal government. When employed at the CIA, Molly worked as an operations officer and Assistant General Counsel. She retired as Chair of the CIA Publications Review Board. She had foreign assignments in West Berlin and the Middle East.

The title of her presentation was "A Brief Overview of National Security Law, Ethics, Leaks, FISA and generally the Craft of Intelligence."

The National Security Act of 1947, following World War II established the United States National Security Council. The CIA was created under the National Security Act of 1947. A post -9/11 revision in December 2004, signed by President George W, Bush brought amendments. Notably, there was a revised definition of national intelligence. "The terms 'national intelligence' and 'intelligence related to national security' refer to all intelligence, regardless of the source from which derived and including information gathered within or outside the United States, that --

- "(A.) pertains, as determined consistent with any guidance issued by the President, to more than one United States Government agency; and
  - (B.) that involves--
- (i.) threats to the United States, its people, property or interests;
- (ii.) the development, proliferation, or use of weapons of mass destruction; or
- (iii.) any other matter bearing on United States national or homeland security."

Molly discussed different Intelligence Community Resources with regulations and policy statements and passed out information if we wanted more detailed accounts.

The CIA is not a law enforcement entity. However it does work with DEA (Drug Enforcement Agency) FBI, Homeland Security, U. S. Military, GWOT (Global War on Terrorism), and others following a complex collection of laws and regulations which address

**Ethics** - for example counterterrorism operations and the need to inform private U.S. entities such as airports, education facilities, etc. of such activities.

**Leaks** - This can include administrative leaks and/or possible criminal intent issues such as Snowden documents, or clear espionage by CIA persons such as Ames and FBI Special Agent Hanssen who passed information to the Soviet Union.

FISA (The Foreign Intelligence Surveillance Act)
What is FISA? "The Foreign Intelligence
Surveillance Act of 1978 ("FISA" Pub.L. 95–511,
92 Stat. 1783, 50 U.S.C. ch. 36) is a United States federal
law which prescribes procedures for the physical and
electronic surveillance and collection of "foreign
intelligence information" between "foreign powers" and
"agents of foreign powers" suspected of espionage or
terrorism.[1] The Act created the Foreign Intelligence
Surveillance Court (FISC) to oversee requests for
surveillance warrants by federal law enforcement and
intelligence agencies. It has been repeatedly amended
since the September 11 attacks."

Both the FBI and the CIA are vital to American security and information gathering. The organizations work cooperatively in some cases where their interests coincide, but have different agency focuses.

CIA has no law enforcement collection function and is mainly focused on overseas intelligence gathering, with only limited domestic intelligence activity conducted in coordination the FBI and usually related to international counterterrorism or counterintelligence.

In the seventy years of of its existence the CIA has lost 125 officers in the line of duty while the FBI in its 117 years of existence has lost only 69. CIA officers do not carry fire arms except in war zones or under special circumstances.

There was discussion of Robert Hanssen who was an FBI agent who spied for Soviet and Russian intelligence services against the United States for 22 years before he was caught. He is presently serving 15 consecutive life sentences and did so much damage. There was also discussion of Edward Snowden who has been called a whistleblower, dissident, traitor or even a patriot.

The topic of Intelligence and Airport Security became so much more important after 9/11. However, it had been an area of terrorist interest and activity going back to 1985 when TWA 847 was hijacked and massacres occurred at the Rome and Vienna airports.

Molly recommended the book *The Craft of Intelligence* by Allen Dulles. Dulles was an officer of the CIA's predecessor--the Office of Strategic Services--and was present at the inception of the CIA, where he served eight of his ten years there as Director. She encouraged us to look at *The Craft of Intelligence* and imagine how a foreign intelligence service might be doing similar things to the United States.

### Lunch with Thad Altman

On December 19th Representative Thad Altman had lunch with representatives from Preserve Brevard, Floridians Against Fracking, Space Coast Chapter of Sierra Club, Space Coast Progressive Alliance, Indian River Lagoon Coalition, and myself representing League of Women Voters of the Space Coast. It was a pleasant lunch, which Representative Thad Altman appeared to enjoy.

I read the League's priorities on Natural Resources: Question: The Florida Water and Land Conservation Amendment of 2014 passed with 75% of voters, but has never been adequately funded. Would you support legislation to mandate that land acquisition have the largest share of funds from the Land Acquisition Trust Fund?

Representative Altman gave a definite yes on cosponsoring House Legislation, and stated his top priority is funding for both Amendment 1 Land and Conservation Florida Forever.

Representative Thad Altman stated he needs help with a massive public relations campaign to advocate funding Amendment 1. He asks to include letter writing, attending court hearings, collecting a million signatures and making a million calls.

LWV Florida Supports full funding of the Florida Forever land acquisition program and proper implementation of the Water and Legacy Conservation Amendment adopted in 2014.

Question: Would you support a statewide ban on fracking, and if not, how do you propose we safeguard our water and natural environment?

Representative Altman gave a definite yes. HB 237 is the House Bill against Fracking & Senate Bill 462 is its companion Bill in the Florida Senate.

2018 House Bill 237: Advanced Well Stimulation Treatment (Fracking)

Summary: Advanced Well Stimulation Treatment: Prohibits performance of advanced well stimulation treatments; provides that permits for drilling or operating wells do not authorize performance of advanced well treatments; provides applicability. Effective date: upon becoming a law.

HB 237 is assigned to the Agriculture & Natural Resources Appropriation Subcommittee. Representative Altman will speak to Representative Ben Albritton who chairs the committee about the committee hearing the bill.

HB 237 is assigned to the Natural Resources & Public Lands Subcommittee. Representative Altman

serves on this committee and will work with the chair Representative Holly Raschein to get the bill heard.

LWV Florida supports the ban of advanced well stimulation treatment (fracking) including but not limited to hydraulic fracturing matrix acidizing.

This was a very interesting and productive meeting. A meeting with seven people representing seven groups saved a lot of office time. I think our strength was in our unity between the different groups attending with one definite purpose.

### Information on Women of Action

#### Stacia Glavas

Stacia Long Glavas is CEO/Founder of Brevard Rescue Mission, a non-profit formed in 2008 to break the cycle of homelessness among women with children. Glavas began her career on Capitol Hill as a legislative aide handling

international trade policy, agriculture, and women's issues. She received a B.S. in Organizational Administration from Oklahoma State University (1985), an M.B.A. from George Washington University (1988), and a M.Div. from Asbury Theological Seminary (2009). After her time on Capitol Hill, Glavas worked as an international trade consultant and then launched her entrepreneurial career as a franchise owner of Maid Brigade, a residential cleaning service in the D.C. metro area. She built the business from 3 employees to over 100, and then turned it over to her husband Pete, who was a former tax lobbyist and Chief of Staff on Capitol Hill, who continued to grow the business, which is still serving thousands of homeowners in D.C., Maryland and Virginia. In 2001, the Glavas family of 5 sold their home and vehicles and moved aboard their 48-ft sailboat and travelled for 2 years from New England to the Bahamas while "boatschooling" their children. In 2003, they settled in Brevard County, FL and set down roots. As she was finishing her seminary degree in Orlando, Glavas served as Asst. Pastor at Georgianna United Methodist Church in Merritt Island. It was a divine appointment when she met a near-homeless woman in front of her home in 2006, which eventually led her to found Brevard Rescue Mission, which has housed more than 100 families, moving them toward self-sufficiency and transformed lives. Glavas' entrepreneurial spirit is evident in the rapid growth and success of Brevard Rescue Mission. Glavas has been married since 1985, has raised three daughters, and lives in Rockledge, Florida.
